1. The Government of India has received financing from the Asian Development Bank (ADB) toward the cost of Building India's Clean Plant Program. Part of this financing will be used for payments under the Contract named above. Bidding is open to Bidders from eligible source countries of ADB.
2. The Principal Scientist (Plant Pathology), ICAR- National Research Centre for Grapes, Pune ("the Employer") invites sealed bids from eligible Bidders for the Construction of office building and laboratory at CPC1-Grapes, Pune ("the Works").
3. Open competitive bidding will be conducted in accordance with ADB's Single-Stage: Two-Envelope bidding procedure and is open to all Bidders from eligible countries as described in the Bidding Document.
4. Only eligible Bidders with the following key qualifications defined in the Bidding Document may participate in this bidding:
 - Minimum average annual turnover of **INR 373 million (USD 3.9 m)** within the last three (3) years;
 - Participation as a contractor, JV partner, or Subcontractor in **at least one (1) contract $\geq$ INR 224 million (USD 2.4M)**, OR at **least two (2) contracts each $\geq$ INR 140 million (USD 1.5M)**, satisfactorily completed within the last five (5) years.
